CALL TO ORDER -

President Kelly called the meeting to order at 5:01 p.m., Commissioner Frey, Commissioner Mee, Commissioner Morrill, Commissioner Pecharich and Commissioner Vires were present.

Commissioner Barrett was absent.

Staff Present included: Executive Director Benard, Executive Assistant Siciliano, Director of Parks & Planning Sperl, Superintendent of Parks and Planning Hinchee, Director of Special Facilities Bendy, Director of Athletics & Facilities Novak, Director of Finance Simpson, Assistant Finance Director Meger, Director of Marketing Wilhelmi, Director of Recreation Beyer,

DISCUSSION ITEMS

Finance and Administration

1. 2022 Annual Comprehensive Financial Report for the Wheaton Park District – Presentation by Seldon Fox Ltd

Annual Financial Report Fund Bottom Line Comparison 2009-2022

Ed Tracy of Seldon Fox Ltd. introduced himself and reviewed Seldon Fox's history of public sector experience. Tracy stated that this is their first year completing the Wheaton Park District's Financial Report under this contract but has worked with the park district in the past. He reported that the process went well with only one small adjustment of \$35. They tested our internal controls to identify any weaknesses and nothing significant was identified. Tracy stated that our books were in good order and no management letter was needed. Commissioner Morrill asked if he thought the park district was in good financial shape. Tracy responded that he thought the district was in good condition.

2. Investment of Wheaton Park District Funds – Presentations by Wheaton Bank & Trust and PMA

Wheaton Bank & Trust CEO Bob Hutchinson, Beth Papini and John Young gave a short presentation. Hutchinson stated that Wheaton Bank and Trust has a long history with the Wheaton Park District with several deposits and investments which are all collateralized in excess of the FDIC limits. Wheaton Bank & Trust made a dedicated effort to offer a Municipal Money Market Account, which the district takes advantage of. Today's rate for this is 5.181%. We currently have a laddered CD schedule with them, with one CD rolling off this month. The proceeds of this CD will be deposited into the MaxSafe Municipal Money Market Account. President Kelly asked if our MaxSafe Municipal Money Market Account is insured. Hutchinson stated it is FDIC insured up to \$3.75 million dollars after that it is collateralized by the bank with government securities. Hutchinson thanked the board for their time and said that they appreciate our business.

Courtney Soesbe Vice President of PMA gave a brief history of PMA. She stated that they strategically diversify across allowable sectors using a ladder approach. She stated that 25% is invested in CD's and 75% is in Treasuries. She stated that their team is tenured. Commissioner Vires asked about liquid rates. Soesbe stated that they keep a small amount in liquid rates. Vires asked about the inverted yield curve. Soesbe stated that it is a slow growth with unemployment being low. The Fed is expected to bump the rate one more time in June but should come down by the end of the year. Rates increased by 2% this time last year. Soesbe stated that by taking investment out 2-3 years at the 4% rate we will have this rate locked in should things fall. They like to have investments spread out over intervals. President Kelly asked if the liquid fund is collateralized. Soesbe said no, but the investments are collateralized. Executive Director Benard stated that \$4.2 million will roll off in August. We would need to change our Investment policy to move funds it to the IPRIME fund, a high yield account offered through PMA. This fund contains high-grade commercial paper, and our current policy does not allow for this type of investment. Benard thought that the board should review this between now and when they roll off. President Kelly asked Soesbe if the BMO Harris Bank CD was one CD or a pool with BMO, Soesbe stated that it was one collateralized CD.

3. Wheaton Park District Board of Commissioners General Practices & Polices – Review of Proposed Amendments

Benard stated that it is a best practice to review this policy periodically. There are only a few cosmetic changes to this policy including changing the time of the board meeting from 7:00 p.m. to 5:00 p.m. and adding a reference to the Local Government Efficiency Act. This item will appear on the June 21 Board Meeting Agenda.

4. Wheaton Park District Advertising and Sponsorship Policies – Review of Proposed Amendments

Benard stated this policy review and update was another housekeeping item. The proposed updates were reviewed. This item will appear on the June 21 Board Meeting Agenda.

Buildings and Grounds

1. **Community Center Interior Renovation Project Phase II** – Design Presentation by Williams Architects and Direct Fitness Solutions

Scott Morlock from Williams Architects provided a design status update for the project. Benard stated that the color schemes presented today are not finalized. Tim Brennan and Mike Munson from Direct Fitness Solutions stated that the biggest change is going to be the amount of space dedicated for cardio machines. People are now utilizing free weights more than cardio so more room will be dedicated to free weights, they are also adding a recovery area. Commissioner Morrill asked if the City of Wheaton has communicated any concerns with the design. Morlock stated that they are following all codes.

Commissioner Frey left at 5:55 p.m.

The locker rooms and The Zone and office areas were discussed. Commissioner Pecharich stated that everything looked great and apparently staff listened to their customers, but she was concerned with the cost of the locker rooms. President Kelly stated that he isn't convinced that the locker rooms will cost as much as they are projecting. We could also do some value engineering to reduce costs. We will bid the locker rooms as an alternate with construction to begin in January. If most of the board wants to pay less for them then we can have the architect re-design them. The new sauna and spa are an ADA requirement since current ones do not meet current standards. Commissioner Morrill said that he is asked by members of Parks Plus Fitness Center if we can add a steam room, so he thought this was a good addition to the locker rooms. He said it looks like a lot of plumbing will need to be moved and understood that this is costly. Commissioner Mee stated he is in favor of the locker rooms not only as a board member but as a member. He thinks this will attract new members. Tom Poulos from Williams Architects stated that upgraded locker rooms are a big need and want from customers, he thinks it will attract members.

Final designs will be presented to the Park Board prior to bids being released.

2. **Community Center Parking Lot Renovation Project** – Review of Bid Results and Recommendation

President Kelly stated that we only had 2 bidders out of the 30 plan holders. The low bid amount came in under budget from a reputable contractor. Commissioner Pecharich asked if we would ever cancel the bids and go back out to bid due to the low number of bids received. Kelly stated we could, but he wouldn't advise it in this case. Superintendent of Planning Hinchee stated that they had a walk through pre bid, and no one showed up. Both bidders are very close except on Alternate One. Commissioner Morrill verified with staff that the work will be completed beginning in late August. Mee was not in favor of the island to re-direct traffic. He asked staff if there was a traffic study or data that would show a need for it. Benard stated we are relying on the staff that work there that see the traffic flow every day. Mee said that he has never seen any problems there. Commissioner Morrill stated that when that parking lot was built it was built

purposely that way to have two exits for emergencies. Benard said that this design maintains both exits. Morrill was not opposed to the island. President Kelly said that we can break out the motion if the board wants to separate the island from the rest of the project. This item will appear on the June 21 Board Meeting Agenda.

3. **Hoffman Park Playground Safety Surface Replacement Project** – Review of Bid Results and Recommendation

Bid results were reviewed. There were no questions from the board. This item will appear on the June 21 Board Meeting Agenda.

4. Cosley Zoo Visitor Center Deck Replacement Project – Review of Bid Results and Recommendation

President Kelly stated that this contractor has worked for us before and is a local company. Commissioner Pecharich asked what we were replacing. Benard stated we are keeping the parts of the deck that are good and only replacing what needs to be. Not the entire deck. This item will appear on the June 21 Board Meeting Agenda.

5. Rathje Park Preschool Roof Replacement Project – Review of Bid Results and Recommendation

Benard stated Redfeather was the lowest bidder. President Kelly stated that this is being replaced at the recommendation of the company that inspects our roofs. Commissioner Morrill asked what we use the Rathje House for and is it used often. Director of Recreation Beyer said that it is well used for preschool and camps. Morrill asked staff for a report on how cost effective it is to keep this facility. This item will appear on the June 21 Board Meeting Agenda.

6. **Atten Park / Springbrook Creek Shoreline Stabilization Project** – Review of Grant Application Proposal for IEPA 319 Program

Director of Parks & Planning Sperl stated that the Wheaton Sanitary District was approved for a grant to stabilize the Springbrook creek through their property. Benard stated that staff is seeking the boards approval to apply for the same grant to complete a similar shoreline restoration project on the portions of Springbrook Creek that runs between Atten Park and the Cantigny Youth Links Property. The board agreed that a grant application could be made and Cantigny be invited to participate. Staff will follow up.

7. **Special Event / Rental Alcohol Sales** – Review of Proposal for Special Event and Rental Related Alcohol Sales in Memorial Park and Central Athletic Complex

Benard stated that these events occur annually, and all prior events have been successfully and safety conducted. Arrowhead staff maintain control of all alcohol sales. There were no questions from the board. This item will appear on the June 21 Board Meeting Agenda.

Additional Discussion Items

1. Purchasing Residency

Benard stated that a non-park district resident inquired about purchasing residency so they would be able to register for programs/camps during the resident priority registration period which begins two weeks prior to non-resident general registration. President Kelly was not in favor of allowing any household who could annex into the park district this option. President Kelly was in favor of this if they were paying as much as the taxpayer. Commissioner Morrill and Mee were also in favor if it was fair to the taxpayers. Staff will follow up.

2. Park Grant

Benard stated that he would like to redirect staff's efforts for the Park Grant application from the Community Center Phase 2 project to the historic structures (Girl Scout Cabin, Boy Scout Cabin, Boat House and Warming Shelter) project. The board previously received a report on the renovation costs of these structures which were significant. This grant would pay 75%. The board agreed.

DISCUSSION ITEMS

Buildings and Grounds

1. **Community Center Interior Renovation Project Phase II** – Design Presentation by Williams Architects and Direct Fitness Solutions

Carrie Kotera from Williams Architect gave a brief presentation that included updates to Parks Plus Fitness Center, the locker rooms and The Zone and office areas. Commissioner Kelly stated that we will go out to bid a week from Friday. The bid documents for this are 95% complete. The locker rooms will be bid as an alternate to give the board more flexibility on approving the bids.

2. **Americans With Disabilities Act Access Audit and Transition Plan** – Review of Proposal from the WT Group

John McGovern from the WT Group outlined his background, credentials and provided an summary of the proposed project cope and related costs. Commissioner Vires verified with Staff that the contract with WT would be paid for from proceeds from the specific tax levy that funds ADA compliance costs and Special Recreation Association membership. President Kelly asked how often we are required to do this. Executive Director Benard said that while there is no set requirement on frequency, having an up-to-date transition plan is a best practice for managing related liability and that it is required as a part of our agency accreditation program. McGovern advised of the potential liabilities for agencies that do not have a current audit and transition plan in place. Commissioner Morrill asked how we did on the last plan we had. Director of Parks & Planning Sperl said that McGovern will assess our compliance progress since our last audit but he

estimates 60% project completion. Sperl explained that new facilities have been added since the last plan was implemented and will be folded into the updated plan. This item will appear on the July 19th Board Meeting Agenda.

3. Briar Patch Park Renovation Project - Review of Bid Results for Backstop Replacement

Benard reported that the district has prior experience with the low bidder, Proline Fence. An OSLAD Grant was awarded for improvements at Briar Patch Park which will reimburse up to 50% of the costs. This item will appear on the July 19th Board Meeting Agenda.

4. Briar Patch Park Renovation Project – Review of Engineering Additional Services Costs

Benard said that the additional services costs were due to the alterations to the pickle ball court design that were discussed at a previous meeting. No further discussion.

5. Mary Lubko Center Roof Rehabilitation Project – Review of Bid Results

Benard reported that the low bidder was Metalmaster Roofmaster. Commissioner Frey asked if it's an all-metal roof. Sperl said yes and added that the existing roof is metal. Commissioner Kelly asked staff to negotiate plywood costs. He also asked that we talk to the attorney about negotiating roof deck work on a time and material basis. Benard stated that we will accept the base bid and negotiate the rest. This item will appear on the July 19th Board Meeting Agenda.

6. **Arrowhead Golf Club Equipment Purchases** – Review of Contemplated Purchases, Cooperative Purchase Program and Quotes

Benard stated that these items are on the budgeted equipment replacement schedule. This item will appear on the July 19th Board Meeting Agenda.

7. Arrowhead Golf Club Asphalt Replacement Project – Review of Bid Results

Benard stated that we have never used Obsidian Asphalt, but Superintendent of Planning Hinchee checked their references, and they all came back positive. Staff will work with the contractor to not disrupt business during the project. This item will appear on the July 19th Board Meeting Agenda.

8. Arrowhead Golf Club Kitchen Equipment Purchase – Review of Ouotes

Benard stated that this deep fryer is replacing the original deep fryer that was purchased when the building was built. This item will appear on the July 19th Board Meeting Agenda.

9. Arrowhead Golf Club Security Camera System Upgrade – Review of Quote

Director of Special Facilities Bendy stated that we are adding a few additional cameras and recording devices. Commissioner Mee was pleased with the LPR (License Plate Reader) cameras. This item will appear on the July 19th Board Meeting Agenda.

10. Cosley Zoo Fence Replacement Project – Review of Bid Results

This will be installed in mid-August. This item will appear on the July 19th Board Meeting Agenda.

Finance and Administration

1. **Investment of Wheaton Park District Funds** – Review of Investment Strategy

Commissioner Vires reported that our policy requires that we match investment timing with cash flow needs. We received good CD rate offers from Wheaton Bank & Trust so he and staff agree on proceeding. Commission Vires asked about potential arbitrage on bond proceeds based on the higher rates of return on short term investments. Benard stated that we spend down the proceeds of bonds within the prescribed spending window which mitigates this concern. In addition, all of our annual issues qualify for the small issue exemption from arbitrage. There Board agreed with this approach. There is no further board action contemplated and staff will carry out the investments as described.

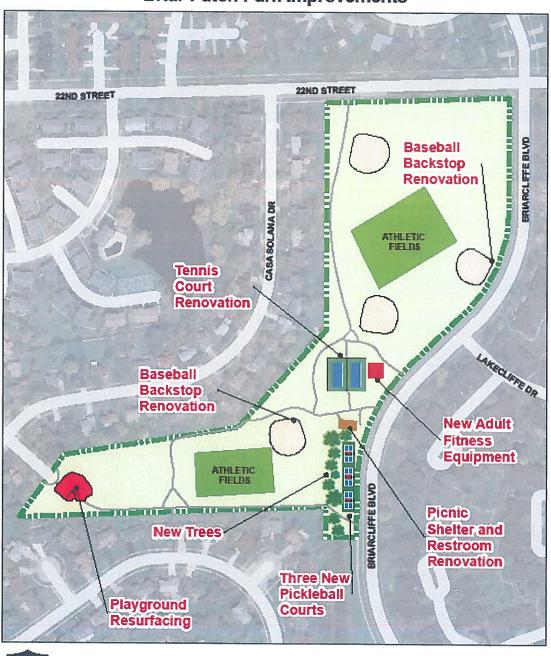

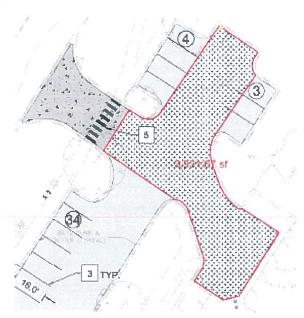

2023 Gasoline and Diesel Fuel Supply and Delivery Bid

The district bids out fuel supply and delivery every three years. Fuel is stored in tanks located at the Park Services Center and Arrowhead Golf Course. Collectively, we use approximately 30,000 gallons of 87 octane gasoline, and 11,500 gallons of off-road diesel that is combined with a biodiesel for cleaner emissions.

With our limited ability to store large quantities of fuel and the fluctuating prices, fuel prices are tied to the wholesale published "OPIS" (Oil Price Information Service) rate. This rate is updated daily and is specific to the Midwest. Since this rate is consistent between the different vendors, our bids are based on a price adjustment factor which is essentially the cost to deliver the fuel to our sites.

Separate pricing was requested for both locations and products, however both vendors provided uniform pricing. Specifications were prepared by staff and sent to 21 vendors. Bids were solicited on August 8, 2023, and they were opened on August 22, 2023. The results were as follows:

Contractor	2023 Contract
Feece Oil Co.	+0.198 per gallon
AL Warren Oil Co.	+0.200 per gallon

This pricing would be effective from December 1, 2023 through November 30, 2024, with the contract issued on an annual basis with the option to renew yearly for up to two years. Feece Oil Co. has been our fuel supply and delivery vendor since 2017, and we have been satisfied with their performance.



REVENUE OR FUNDING IMPLICATIONS:

- \$130,250 is budgeted for total park district fuel and delivery within the current 2023 fiscal year, and also the same for the upcoming 2024 fiscal year. The budget breakdown is \$75,000 for the Parks Department (Acct. #10-101-000-53-5348-0000); and \$55,250 for Arrowhead Golf Course (Acct. #60-601-000-53-5348-0000).
- Non-fuel lubricants, motor oil and anti-freeze are not included in this budget.

Several sections of deteriorating, chain-link boundary fence have been identified throughout Graf Park. These include the replacement of the fencing along the railroad tracks, (on both the park and Monroe Middle School sides of the property), and along the DuPage County Fairgrounds boundary line. Additionally, a small fence and gate, needed for security under the press box for the football field, needs to be replaced.

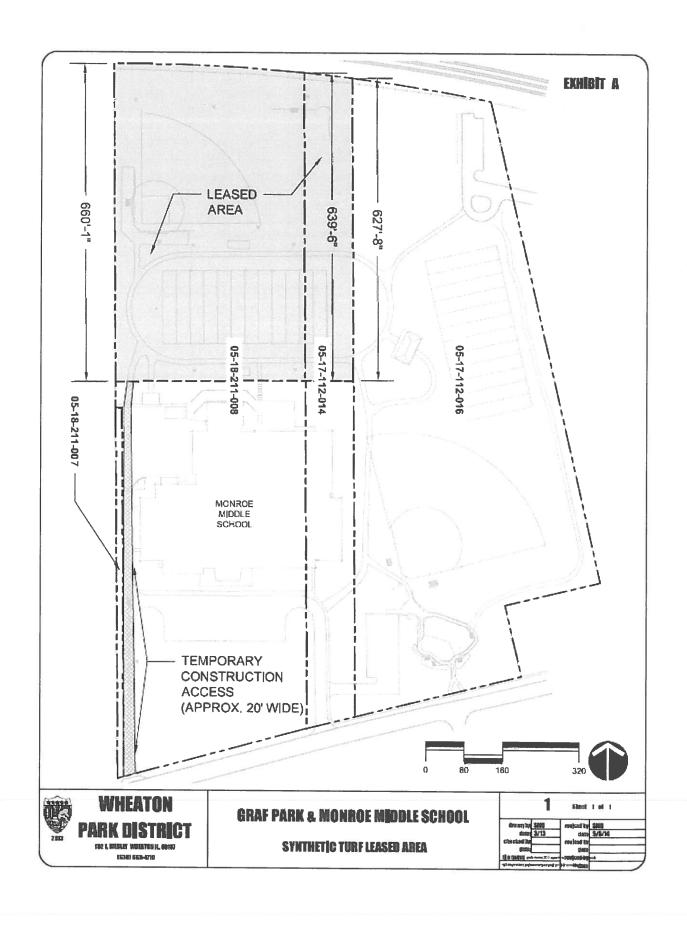

We have budgeted to replace our 2011 Ford E350 Lift Truck. This vehicle is primarily used by our electrician to access lights and fixtures throughout the district. This vehicle is also used to store all of their equipment and supplies for electrical maintenance. On occasion this vehicle is used by our conservation manager for tree pruning in accessible areas that are closer to the ground.

It is typically a custom-built vehicle and not something available in stock. We have attempted to obtain a state purchasing price since March and have been unsuccessful. There are few manufacturers of these types of vehicles. We have obtained pricing from two of them. The chassis these are built on is a Ford 350 van. The lift components are substantially similar.

PREVIOUS COMMITTEE/BOARD ACTION:

The board has previously approved vehicle purchases annually through state purchasing when possible and based on vehicle availability. In May 2023, staff was permitted to purchase trucks though a board approved resolution Ratifying and Approving the Emergency Expenditure of Funds Without Competitive Bidding for the Purchase of Certain Vehicles with 3 quotes due to the uncertainty of vehicle availability through the state purchasing program.

REVENUE OR FUNDING IMPLICATIONS:

\$138,000 is budgeted for replacement of our current Lift Truck (#1116) in the FY2023 Budget (10-101-000-57-5706-0000).

We will eventually declare the current lift truck surplus and sell it via auction. However, we would like to retain it through the next year to allow us to catch up on tree pruning throughout the district.



STAKEHOLDER PROCESS:

LEGAL REVIEW:

A new resolution "Ratifying and Approving the Emergency Expenditure of Funds Without Competitive Bidding for the Purchase of Certain Vehicles" similar to what was approved earlier this year for truck purchases has been prepared by our attorney.

ALTERNATIVES:

It would be possible to go out to bid for this vehicle. This would require creating specifications that are based on either one of the comparable vehicles. The other bidder would have to be considered an "as equal" bid which may be challenged by the specified bidder. We would likely see higher prices due to bidding requirements such as the need to provide a bid bond that has been a deterrent to bidders on other projects.

RECOMMENDATION:

Staff recommends the Board of Commissioners approve Resolution 2023-07 and the purchase of a 2023 Duralift DVT-29TS Truck through Runnion Equipment Company at a cost not to exceed \$116,900.

WHEREAS, the Wheaton Park District ("Park District") owns, operates, and maintains a fleet of vehicles, and, to help ensure the quality and safety of said vehicles, schedules replacement of vehicles that have reached the end of their expected useful life for Park District operations; and

WHEREAS, after reviewing the current vehicle replacement schedule as well as assessing the Park District's current needs, Park District staff recommends replacing its 2011 Ford E350 Lift Truck and purchasing a new 2023 Duralift DVT-29TS Truck;

WHEREAS, the lift trucks utilized by the Park District are typically custom-built vehicles, with few manufacturers and are not typically available in stock; and

WHEREAS, the Park District typically utilizes the State of Illinois' Joint Purchasing Program or other authorized joint purchasing cooperatives for vehicle purchases; and

WHEREAS, the State of Illinois and other joint purchasing cooperatives have delayed releasing 2023 vehicle pricing on multiple occasions and/or cancelled existing orders due to unexpected price increases and market instability caused by the ongoing COVID-19 pandemic and supply chain related issues, among other reasons; and

WHEREAS, the Park District also learned that the ongoing impacts to pricing, production, and vehicle order lead time is impacting local dealers inventory and the ability to fulfill preorders in a timely fashion; and

Administration/Overall Department

• Park Permitting – Thirty-five reservations were held in August and thirty park reservations have been reserved for future dates.

- Two September rentals were booked for the new Sensory Playground picnic area. The area is woodchipped and covered with a 20 x 40 tent. It includes six picnic tables hosting up to a capacity of fifty.
- Commemorative Program Three commemorative benches were installed in August.
- Our end of the season staff picnic was held on August 11. We had a great seasonal staff this summer and hope many of them return next year.
- After interviewing several candidates, the Parks Department is welcoming Nate Teske from Cosley Zoo as the new FT Assistant Mechanic beginning September 6th.

Planning

- Bids to replace the northern boundary fence at Graf Park and the backstops at Scottdale were received.
- Bids were also received for the Briar Patch Park improvements.
- The PPFC was successfully relocated to the other end of the hall and work for the interior renovations are set to begin shortly after Labor Day.
- Work on the Community Center parking lot began in mid-August. Two minor changes for additional work are included in change order 1.
- Several projects at Cosley Zoo, including replacement of the deck at the gift shop, the fence along the entrance, and timber walls are underway.

Parks & Buildings Operations

- The electrical trim and sound system were finished in the Graf press box. Both Graf scoreboards were checked for operation and bulbs replaced where needed for the start of football season.
- The electrical set-up and take down for Brewfest was completed.
- Playground equipment replacements were installed at Hillside, Triangle,
 Brighton Community Center, and Northside Parks as identified during our routine inspections.

- Information CAT6 cable runs at PSC, Community Center, Cosley Zoo, Northside Pool, Mary Lubko Center, Clocktower Commons, and Rice Pool, were completed as a part of our POS system upgrades.
- Rotary fountain repair to the water supply line from the pump to the top of the fountain was complete, the old hose had degraded and cracked.
- Performed storm drain checks on all district drains.
- New floors were installed at Rathje by an outside contractor and staff painted the new base shoe. Repaired paneling and painted Rathje upstairs restroom and a new children's toilet was installed.
- Checked and performed scheduled maintenance on all pond bubblers to ensure efficient operation.
- Hurley Gardens shed had three courses of block added to the height of the
 walls, a new roof installed, new concrete floor poured, and a new
 commercial steel door installed. Trenching and conduit installation were
 completed from the shed to the new water feature location and the trench
 backfilled. The concrete block foundation for the new fountain was installed
 to support the structure.
- Replaced a fuse for the CAC Musco sport lights. This has been a recurring problem and further investigation has found a problem with the transformer windings being burnt. A new transformer will be ordered to rectify the problem.

Projects and Special Events

- Demolition at Hurley Garden Fountain. Jackhammered and removed all old concrete from the fountain at Hurley Gardens
- Signs and banners for the Cosley Classic Golf Outing were completed.
- Hoffman Playground construction. Demolition and excavation of old mulch and dirt is completed. New curb frames began the last week of August.
- Memorial Benches and plaques at Lincoln Marsh, Briarknoll, Madison and W.W. Stevens have been installed.
- Shakespeare in the park set up, staffing and breakdown took place.
- Set up and take down for the Summer Concert Series at Memorial Park.

Horticulture, Turf & Natural Resources

 Orchard Park received some needed attention in August. Old shrub beds that had fallen into disrepair were cleared out, backfilled, and overseeded. The backfill material was from excess soil that was left over from the new Scottdale T-ball field project.

- Numerous athletic fields and high-profile areas were aerated and overseeded, including: Graf, 7 Gables, CAC, Orchard, Toohey, Northside, and Memorial Park. Staff will follow up with fertilizer and weed control.
- Repairs were made to the limestone screening path at Northside Park. Low areas that had been washed away during storms have been backfilled, leveled, and compacted.
- Pond maintenance has been particularly challenging this year. Staff are
 working closely with our pond management contractor to keep the algae
 under control. It is believed that the above average rainfall, plus high
 temps lead to the excessive amounts of algae and duckweed.
- Staff cleared the fence line along the north side of 7 Gables Park.
- Trim crews continue mowing, trimming, and weeding parks on both sides of town.
- The mowing crew continues the weekly routine of cutting grass throughout the parks.
- Striping of the soccer, football and lacrosse fields continues on a weekly basis.
- Ballfields are groomed per the schedule daily.
- Staff assists with weekly garbage pick-up throughout the parks.
- Staff continue to water the annuals and all newly planted trees and shrubs.

Conservation

- Storm damage clean up and tree work continues throughout the district.
- Lincoln Marsh work orders were completed.

Fleet Mechanics

- Two new 7x18 flatbed trailers have been added to the trailer fleet and prepped for service.
- The zoo's new Gator utility vehicle was delivered and is being prepared for to put in service.
- The Genie lifts at Arrowhead, Community center, Central Athletic Complex and Memorial Bandshell all received their annual inspections.
- Various hydraulic and equipment services were completed this month.

General Revenue/Fundraising:

- The zoo received August operational donations of \$8,065. This brings the 2023 donation total to \$56,650 (not including donations made to the Cosley Foundation).
- In August public duck and chicken feeding opportunities earned \$5,197, bringing 2023 total revenue to \$20,817. Public feedings will continue through mid-October.
- The gift shop and concessions operations continue to do well, having earned gross revenue of \$160,974 as of the end of August, compared to \$155,015 in 2022.

Education Programs and Activities:

- Program and facility rental income is continuing to improve, earning gross revenue of \$159,362 by the end of August. This compares very favorably to 2022 when revenues total \$120,059.
- A total of 51 teens have joined the Junior Zookeeper program for 2023/2024. They will undergo orientation in September.
- The annual Junior Zookeeper trip took place on August 2, with 25 teens making the trek to Lincoln Park Zoo. The teens were treated to special experiences and lunch with some participants from Lincoln Park's teen program.
- On August 11, five teen King Conservation Science Scholars from Brookfield Zoo visited Cosley. During their visit, the teens were able to participate in duck feeding, Coyote Connection program, animal encounters provided by Cosley Zoo JZs, and lunch with several of our teens.
- In support of International Save the Vaquita Day, Education Specialist, Kelly Golbeck put together information on sustainable seafood for two of our JZs to present to interested guests.

- Two of our JZs earned a Zookeeper for a Day experience. JZs are eligible for this
 opportunity to shadow a zookeeper for an entire day once they have reached 225
 cumulative hours.
- The education team welcomes new fall intern Stephanie Delatorre who has previously completed an animal care internship. Stephanie is trying to gain more experience to pursue a career as a zoo educator.

General Activities:

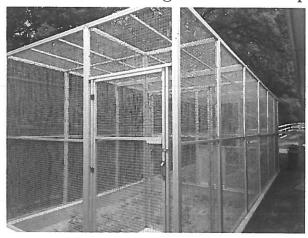
- The 40th annual Mike Williams Cosley Classic Golf Outing was a sell-out event with 166 golfers. A beautiful day complete with lunch, dinner, gimmicks, raffle, and awards made for a great event.
- The zoo welcomed full-time zookeeper Teddy Argentum and part-time zookeeper Mason Cargola to their team. Teddy previously worked at Cosley Zoo in the capacity of intern

- as well as part-time zookeeper. He returned to Cosley Zoo from his full-time position at Phillips Park Zoo,
- Strategic planners Jill Allread and Elizabeth Hennig from Public Communications, Inc. (PCI), conducted focus groups with zoo staff. PCI also developed surveys that will be sent to zoo staff, zoo and park district leadership, and zoo donors and members.
- The zoo held its annual donor appreciation event on August 24. Extreme heat conditions required a last-minute pivot from holding the event at the zoo to hosting it at Arrowhead. More than 70 supporters signed up for the event. Attendees enjoyed a special presentation by Anima Glen Ellyn Childrens Chorus as well as great food and drink provided by Arrowhead.
- The wood deck on the south and east sides of the train station was replaced by contractor Wallfill.
- Staff welcomed a mini Falabella horse named Dolly, who is a mere 31" tall from the ground to the top of her shoulders. The zoo also became home to two adult female porcupines who are currently spending a minimum of 30 days in quarantine. Also joining the zoo are a xanthic (yellow color mutation) Blanding's turtle (for use in education)





- During August staff supported several VIP tours with potential donors.
- A replacement outdoor enclosure for use by ambassador animals as well as emergency holding was installed by Corners Limited in August. Staff will be finishing the project by installing wire in the bottom of the enclosure (to prevent egress via digging) and adding appropriate substrate. The new enclosure offers more safety and flexibility with double entry doors and a shift door allowing the area to be split into two sections.

Banquets

- In August, the banquets team held 50 events.

- In August, Arrowhead Restaurant welcomed 7,840 guests.
- Chef Jon and his kitchen staff have created weekly specials for lunch and dinner. They have featured Whitefish panini, Chicken Parmesan Sandwich, Marinated Peaches and Burrata, Hanger Steak Salad and the Pasts alla Norma.
- The restaurant had 6 private events in August.
- Staff hosted another cooking class on August 19: Grilled Desserts. The chef shared his grilling tips and techniques, while enjoying samples and Champagne.
- Here are some nice reviews guests left on OpenTable:

"BLT panini was very good. Bacon was crisp and not soggy. Tomato soup very good as usual. Tiramisu was very good. The decorations of sauces on the plate was delicious and pretty. Our server Kathy was exceptional. She made sure to check on us numerous times.

<u>Arrowhead Golf Club</u> <u>Director of Golf Operations Bruce Stoller</u>

- August temperatures averaged near normal even though it saw two record high temperatures, the first triple digit reading since 2012, and the highest heat index ever recorded in our area. It was also very dry as we only saw about 31 percent of normal rainfall and the area moved back into the first stage of drought.
- We hosted five large outings during the month with all of them utilizing the banquet hall for their post golf events. Three of the five were charitable fundraisers while one was a political fundraiser, and one was hosted by a trade organization.
- Arrowhead is again hosting the boys and girls' teams from Wheaton North and South with tryouts taking place early in the month and matches starting the following week. The state tournament schedule has been moved up this year so the majority of activity will conclude before the end of September.
- Staff continued our relationship with Women on Course by hosting multiple lesson and playing opportunities for their members and guests.
- Interest in large golf outings has been very strong for 2024 with a renovation project at an area course leaving several groups looking for a location for their 27-hole events.
- Staff met with two companies to begin the process of updating our GPS units after the current lease expires in November. A third company sent a demonstration unit so we could see it firsthand and test functionality.
- Building maintenance projects have included: installing locking drain covers in the kitchens; repairing the panini press, Quarterly cleaning of multiple ice machines, a leak in the wall behind the main dishwasher; patching a crack in a mop sink; installing a

new compressor in a kitchen line cooler; pulling wire and starting to install new security cameras; replacing the battery backup for the computer system; working with AIE to switch to a new backup internet line; cleaning air vents; spot cleaning carpeting.

Grounds maintenance projects have included: completing evaluations and end of year
paperwork for part-time staff leaving for school; clean-up after a couple of strong
thunderstorms; combated the extreme heat and humidity by applying chemicals to
assist with water retention and disease prevention, hand watering greens, spot irrigating
fairways, and adjusting mowing practices.

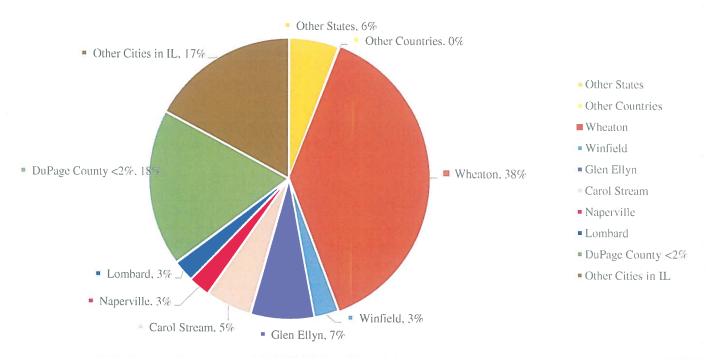
- Manager continued daily coordination with the contractor during the restoration project.
