- 1. Memorial Park Renovation Project Recommendation to approve change order No. 1 from Frederick Quinn Corporation
 - a. Change from clay pavers to concrete pavers at parking lot. Reduce attic stock. Establish an allowance amount for the sum of \$22,975
 - b. Establish a \$10,000 allowance for expenses that may arise as a result of permit delays. Amount to be deducted from \$22,975 allowance from change order #001
- 2. Memorial Park Renovation Project Recommendation to approve change order No. 3 from Frederick Quinn Corporation
 - a. Fees related to the closure of the sidewalk on Wheaton Ave for the sum of \$2,835.
 - b. Masonry changes at stage bumpout (necessary because NICHIHA panel is limited to 72 inches), addition of slip joint due to material change from concrete to clay based brick, additional dowels at stage wall cap for the sum of \$4,926.
 - c. Power for ADA operators for the sum of \$1,469.
