**A RESOLUTION AUTHORIZING WHEATON PARK DISTRICT
PERMISSION FOR POSSESSION AND CONSUMPTION OF
ALCOHOL AT THE ACCESSIBLE TREE HOUSE
FUNDRAISER**

WHEREAS, the Forest Preserve District of DuPage County and the Wheaton Park District entered into a lease for a portion of the Lucent East Parcel (Lease Agreement); and,

WHEREAS, the parties agreed in the Lease Agreement that the Wheaton Park District shall comply with all District ordinances; and,

WHEREAS, the alcoholic liquor may be possessed or consumed on District property with the prior consent of the Board of Commissioners; and,

WHEREAS, the Wheaton Park District wishes to hold an event, the Accessible Tree House Fundraiser, with beer, and wine on Thursday, August 16, 2018, between 5:30 – 7:30 p.m.; and,

WHEREAS, the Wheaton Park District has asked the President and Board of Commissioners for permission for beer and wine to be possessed and consumed as part of the Accessible Tree House Fundraiser on August 16, 2018.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Commissioners of the Forest Preserve District of DuPage County as follows:

1. The Wheaton Park District is granted approval for possession and consumption of beer and wine in conjunction with the Accessible Tree House Fundraiser on August 16, 2018.
2. The Secretary is directed to transmit a certified copy of this Resolution to the Executive Director Michael Benard of the Wheaton Park District.


