To the fullest extent permitted by law, 4 The Beat Band shall indemnify and hold harmless the 2016 Cosley Uncorked committee its officers, officials, employees, volunteers and agents from and against all claims, damages, losses and expenses, including but not limited to legal fees (attorney's and paralegals' fees and court costs), arising out of or resulting from the entertainers' activities; except to the extent caused in whole or in part by any negligent or wrongful act or omission of a party indemnified hereunder. 4 The Beat Band shall similarly protect, indemnify and hold harmless the 2016 Cosley Uncorked committee, its officers, officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees, incurred by reason of Diva Montell's breach of any of its obligations under, or Diva Montell's default of, any provision of the agreement.
