Replace CC switches in server room, and front desk. (Switches to be replaced are WPD-ESW01-CC01, WPD-ESW02-CC01 and WPD-ESW06-CC01.)

Prairie Office Building

Replace switches at Prairie Office Building with new Meraki switches. (Switches to be replaced are WPD-ESW01-PB01, WPD-ESW02-PB01, and WPD-ESW03-PB01.)

Clocktower Commons

Replace WPD-ESW01-CLK01 with a new Meraki switch.

The DuPage County Historical Museum also has a switch which is end of life and needs to be replaced. When we re-cable the Prairie Office Building, we will have an extra 24-port Meraki switch that will be repurposed for the Museum location, to replace WPD-ESW01-MUS01. The Prairie site is a high priority for switch replacement and cannot wait until the cabling has been replaced. We will bill the time to replace the Meraki switch at the Museum as a part of the Prairie rewiring project.
