In the event that this performance is cancelled by the officials of Cosley Zoo Event due to inclement weather, Aaron Dorf agrees to be rescheduled for another performance for Cosley Zoo event, date to be determined and agreed on by performer. If inclement weather occurs, the event and its officials will do everything in their power to go on with the schedule. Bands must understand that their performance times may be adjusted slightly (forward or back) to accommodate any unforeseen circumstances.


