The Cream of Wheaton is not responsible for the entertainers' personal property and shall not be liable for any damages, lost, or stolen property. All cords, cables, equipment etc. must be properly and safely positioned so as not to create a trip hazard for patrons and staff.

In the event that this performance is cancelled by the officials of the Cream of Wheaton due to inclement weather, Acrodazzle, agrees to be rescheduled for another performance at the Wheaton Park District, date to be determined and agreed on by performer. If inclement weather does take place the event and its officials will do everything in their power to go on with the schedule. Entertainers must understand that their performance times may be adjusted slightly (forward or back) to accommodate any unforeseen circumstances.

To the fullest extent permitted by law, Acrodazzle shall indemnify and hold harmless the Cream of Wheaton committee its officers, officials, employees, volunteers and agents from and against all claims, damages, losses and expenses, including but not limited to legal fees (attorney's and paralegals' fees and court costs), arising out of or resulting from the entertainers' activities; except to the extent caused in whole or in part by any negligent or wrongful act or omission of a party indemnified hereunder. Acrodazzle shall similarly protect, indemnify and hold and save harmless the Cream of Wheaton committee, its officers, officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees, incurred by reason of Acrodazzle breach of any of its obligations under, or Acrodazzle default of, any provision of the agreement.

The Wheaton Park District reserves the right to cancel this agreement at any time for breach of this agreement, or for any reason other than breach of contract upon 7 days notice provided to the entertainers.
