1. To install one new Accu-Tab Chlorinating System. Complete installation and parts. 3140AT Powerbase NSF approved when used with 3" Accu-Tab Calcium Hypochlorite. At a flow rate of 60 gallons per minute through feeder, chlorine delivery is 7.36 lbs. per hour.
2. To install one new Accu-Tab Chlorinating System. Complete installation and parts. 3500 Powerbase NSF approved when used with 3" Accu-Tab Calcium Hypochlorite. Delivery rate 36.41lbs. per hour.

Note: Your facility needs to install a 120 volt GFIC 20 amp dedicated outlet with in four (4) feet of each powerbase chlorinator unit.

The unit as specified is NSF/ANSI Standard 50 approved. The manufacturer of Accu-Tab and NSF International (NSF) only recognize the use of **Accu-Tab Blue** chlorination tablets as the proper chemical for use in pool applications with **Accu-Tab** feeders. Since Illinois subscribes to NSF Standards, use of anything but **Accu-Tab Blue Tablets** in your **Accu-Tab** feeder would not only void the NSF/ANSI 50 Certifications, but also be out of compliance with the state health code requirements.
