SUMMARY:

As directed by the Board of Commissioners, Arrowhead solicited the services of a food and beverage consultant PFF-Profitable Food Facilities Worldwide in January 2019. After a review of the kitchen and banquet back of house, they determined a need for a new dishwashing system in the restaurant and banquet areas. Not only did they feel the current dishwashers were coming to the end of their life cycle (13 years old) they also felt the new units could possibly save on labor.

Staff held a prebid meeting at Arrowhead for all interested parties on June 26, 2019. Plans and specifications were prepared by staff and bids were solicited on June 19, 2019. The bids were opened on July 2, 2019 and the results were as follows:
