

STATEMENT OF WORK

This Statement of Work ("SOW"), dated June 16, 2021, is entered into by and between Athletico Management, LLC and Wheaton Park District (the "Agreement").

Event Schedule and Compensation

Athletico to provide one (1) Athletic Trainer to provide the Services, and Client shall pay Athletico for the Services as follows:

However, Client agrees that such coverage is not guaranteed and shall be provided by Athletico only to the extent it has an athletic trainer available for such events. Athletico shall have no obligation to provide such coverage. Client further agrees Athletico shall have no liability to it if Athletico fails to provide such coverage.

Miscellaneous

- Client shall name Athletico as "The Official Provider of Physical Therapy and Athletic Training for the club" in all press releases, radio spots, newsletters, related materials and website. Athletico will be designated as the exclusive provider in the Physical Therapy, Occupational Therapy, Athletic Training, Work Rehab, and Sports Medicine Category.
- ii. Client shall educate the players and parents of their club on the importance of medical care and follow-up if necessary with an Athletico facility after injury.
- iii. Client shall be responsible for all expenses incurred by the athletic trainer including parking and food.
- iv. Client shall establish a link, logo, and information pertaining to all Athletico services to Client website.
- v. Client shall allow Athletico to display banners at event sites.
- vi. Client shall provide Athletico with access to facilities, at no cost, as necessary to carry out its responsibilities under this SOW.
- vii. Client shall reimburse Athletico for all mileage incurred in providing the services hereunder at a rate per mile equal to the then-prevailing federal IRS mileage rate for business purposes.
- viii. Client shall cooperate with Athletico in all other respect to achieve the objectives of this SOW.
- ix. Athletico shall provide on-site injury care and evaluation as well as assistance on all matters pertaining to the health and well-being of the participants and athletes, including, without limitation, the coordination of follow-up treatment and rehabilitation as necessary for all injuries sustained by participants and athletes.
- x. Athletico shall provide education to coaches, participants, and athletes on the importance of medical care and follow-up necessity with an Athletico facility after injury.
- xi. Athletico shall provide basic medical supplies. If Client requests supplies that are not included in Athletico's medical kit, Athletico will assist Client in ordering such supplies and Client will reimburse Athletico for the cost of supplies.
- xii. Athletico shall provide preferred pricing through current vendor relationships for athletic training supplies and concussion baseline testing purchased by Client.
