Music shall not be offensive, vulgar, obscene, or inappropriate for the ambiance and atmosphere of the Cosley Uncorked Wine Event. Entertainers shall at all times conduct themselves professionally, courteously and appropriately for this family-friendly facility.

Entertainers are solely responsible for properly setting up their equipment and removing equipment. Event staff are not responsible for the entertainers' personal property and shall not be liable for any damages, lost, or stolen property. All cords, cables, equipment etc. must be properly and safely positioned so as not to create a trip hazard for patrons and staff.

To the fullest extent permitted by law, Ben Weaver shall indemnify and hold harmless the Wheaton Park District, Cosley Zoo, its officers, officials, employees, volunteers and agents from and against all claims, damages, losses and expenses, including but not limited to legal fees (attorney's and paralegals' fees and court costs), arising out of or resulting from the entertainers' activities; except to the extent caused in whole or in part by any negligent or wrongful act or omission of a party indemnified hereunder. Ben Weaver shall similarly protect, indemnify and hold and save harmless the Wheaton Park District, its officers, officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees, incurred by reason of Ben Weaver breach of any of its obligations under, or default of, any provision of the agreement.

The Wheaton Park District or Cosley Zoo reserve the right to cancel this agreement at any time for breach of this agreement, or for any reason other than breach of contract upon 7 days' notice provided to the entertainer.
