

Entertainment Agreement

This agreement is for entertainment services pertaining to the engagement described below, made this day, **November 9, 2017** between **Brian Allison & Cheryl Rodey** (herein referred to as BRIAN & CHERYL) and Linda Dolan (herein referred to as HOST).

Wednesday, February 21st 2018 1-2pm Brookdale Glen Ellyn, IL:

HOST hereby agrees to hire the professional services of BRIAN & CHERYL, as an independent contractor, for the date of **Wednesday, February 21st, 2018**.

TERMS OF AGREEMENT:

- (1) BRIAN & CHERYL agrees to provide all necessary instruments and sound system / PA for performance as needed/ requested. BRIAN & CHERYL reserves the right to move, reposition, and relocate such equipment in the interest of avoiding damage to same. Any and all damages to HOST'S equipment as direct result of malice, negligence, or accident by hosts, guests, attendees, servers and/or employees, pets, children, etc. are the responsibility of HOST.
- (2) HOST agrees that BRIAN & CHERYL may take one 10-minute break for every Two (2) hours of performance.
- (3) For outdoor engagements, HOST agrees to provide BRIAN & CHERYL with complete protection from rain, snow, and extreme temperature conditions and to provide a **flat, completely dry** (electrical equipment hates water), solid surface with adequate space. If weather or other unplanned natural calamity does not permit BRIAN & CHERYL to perform, HOST agrees to relocate BRIAN & CHERYL indoors. If this is not possible, HOST agrees to pay performance fee in full.
- (4) Electricity (One 3-prong electrical outlet or extension cord – 110v) will be supplied by HOST, within 10 feet of the exact site of performance.
- (5) BRIAN & CHERYL may sell their original CDs, unless arranged otherwise by the host.

COMPENSATION:

For professional services rendered, HOST agrees to pay BRIAN & CHERYL monies in the sum of \$200, with a minimum Two (2) Hour fee. Payments may be made in the form of cash, check, or money order.

DEPOSIT:

A Fifty Dollar (\$50.00) non-refundable deposit is due upon the execution of this contract to reserve the scheduled date and time. The balance is due on the date of the performance. Said deposit can be mailed to:

In the event of cancellation less than Twenty-Four (24) hours in advance of said performance, Host agrees to pay BRIAN & CHERYL the full balance of the minimum 2 hour performance of Two Hundred Dollars (\$200). If cancelled less than One (1) week, but more than Twenty-Four (24) hours, in advance of said performance, Host agrees to pay BRIAN & CHERYL a partial balance of One Hundred Dollars (\$100). If cancelled more than One (1) week in advance, no additional payment is necessary beyond the non-refundable deposit.
