Jim,

The following are the costs you requested.

- 1. Remove an existing roof drain and replace it with a new drain assembly. The unit cost for this work is \$1,500.00 per drain. At this time we have only discovered one bad roof drain.
- On roof area C the tapered insulation has been eliminated. This was done due to height limitations.
   Weeps in the masonry wall were uncovered. This restricted the height of our roof flashing. The credit for eliminating the tapered insulation is \$3,120.00.
