Payment will be made 30 days after receipt of invoice, either in-advance, or the week following the performance, regardless of whether Jest Entertainment has sent an invoice. Client understands and agrees that a late fee, (\$50), will be assessed if not paid in full after 30 days from date of show, per month. Please don't ask our actors to be responsible for your payment. The deposit is non-refundable. Gratuities are not expected but are appreciated and should be given directly to the actors. Client furthers agrees that, if account is 30 days past due, any credit card numbers previously supplied to Jest, may be used to pay any unpaid balance.

3. No date and time will be held until this agreement is signed by client and "Jest", a signed copy is delivered to "Jest Entertainment, and a deposit is received.

4. The Client assumes full responsibility and liability for any losses that may develop from the event stated in this contract.

5. "Randy Manning's Jest Murder Mysteries", [www.JestMurderMystery.com](http://www.JestMurderMystery.com), and 888-234-9984 is to be mentioned on every flyer, announcement, card, poster, radio, newspaper article, press release, television, etc.

6. Jest Entertainment will not be responsible for cancelled shows due to inclement weather, impassible roads, accidents, illness, etc. Nor do we guarantee specific actors for specific shows.

7. The price quoted above is not locked in until plane tickets have been purchased. No actors will be booked, and no plane tickets will be purchased, until the deposit is received. Client agrees to not disclose specifics of any agreed upon price to any other parties.
