## AGREEMENT FOR IMPRINTED SPORTSWEAR SERVICES

This agreement between Northwest Designs of Illinois, Inc. and Wheaton Park District is to cover the dates of May 17-19, 2013. Northwest Designs of Illinois, Inc. will exclusively provide the official event specific imprinted apparel for sale at your upcoming event(s) **Wheaton Wings Spring Classic Tournament**.

### Northwest Designs of Illinois, Inc. SHALL:

- Provide the staff of our graphic arts department to design the artwork with your approval for your official event logo at no cost or you may provide your own if desired.
- Provide roster typesetting & printing of all names of event participants provided by your organization at no cost.
- Provide adequate staffing for all events during this agreement period at no cost.
- Set-up at both locations as needed during your event.
- Provide all inventory and a wide variety of style selections for sale at the event(s) listed above at no cost.
- Provide all items to further personalize the apparel, such as: player Numbers for the sleeves, Champions, Medals, etc.
- Pay 20% of the net sales if total is under \$5000 and 22% if total is over \$5001 to your organization.
- Provide 40 Staff or Volunteer t-shirts imprinted with event logo and Staff or Volunteer at no cost.
- Provide generators if electricity is not available.
- Retain exclusive rights to the event design/artwork if generated by our art department.

### Your Organization : Wheaton Park District SHALL:

- Provide dates and schedule of the event as soon as possible.
- Provide a minimum of 80% of the names of participants within 2 weeks prior to the event unless other arrangements are made.
- Provide highly visible set-up location, tables if available.
- Grant exclusive rights for event specific apparel to Northwest Designs of Illinois, Inc. and shall not allow any other party to offer the Official logo apparel items ( other vendors, pro-shops, etc.). This includes any apparel with event specific logo, title & date, or action photos which can be construed as event specific.
