

SUA – Suburban Umpire Association

Softball Service Agreement

This Contract shall commence on day of June 19, 2013 Don J. Kochniarczyk for the 2013 RWB Tournament.

Suburban Umpire Association hereinafter shall be referred to as SUA and Wheaton Softball Red White & Blue Tournament hereinafter shall be referred to as Wheaton.

Time of Contract and Scope of Services

Officiating will start upon an agreed date and will be finalized per the dates provided by Wheaton to the SUA and adjustments be allowed if needed.

SUA per contract will schedule officials to Wheaton at locations and times specified by submitted schedule within a timely manner prior to the Tournament start in 2013.

SUA will provide Wheaton (RWB Tournament Director) a list of officials and their NSA Number.

Added: SUA: officials will be dressed in NSA apparel and registered with NSA without exception. ✓

Added: SUA: will provide a certificate of insurance to the Wheaton Park District prior to Tournament start.

Added: SUA Board member (Don Kochniarczyk) will UIC the **Wheaton RWB Tournament** and be on Site from Tournament first pitch until Tournament final pitch.

Added: SUA will have a three umpire rotation if needed in games that require two officials.

Game Pricing

- **Tournament: \$45.00 per Official per game.**
- **Tournament: \$40.00 per Official for two (2) officials per game or \$80.00 per game.**
- **Umpire-in-Chief fee is ~~\$300.00~~ 250.00**
- **One delivered pitch constitutes a full game fee which all head coaches and teams should be aware of in order to save the Wheaton expenses.**
- **Don Kochniarczyk will be the Umpire-in-Chief for the Wheaton RWB Tournament.**
- **Assignors scheduling fee of \$100.00 shall be paid upon signing of the Contract.**

Tournament Schedule.

- Tournament schedule to be submitted a least one week prior to Tournament schedule.

Payments to SUA

Payments to SUA in accordance with Contract pricing shall be within 30 days of invoice.

Wheaton treasurer, shall submit phone and email numbers for communication purposes to SUA treasurer with first payment.

General Provisions and Notices

- ✓ Officials representing SUA shall perform in a professional manner in compliance with all applicable rules and standards and have a pregame meeting with Head coaches prior to start of game.
- ✓ Officials are required by SUA to provide quality work, knowledge of rules, game procedures and to be present at game site prior to game/contest time without exception.

In the event Wheaton fail to remit payment due hereunder, SUA may cease work without breach pending payment or resolution of said dispute.
