Community Center Filter Room Roof Bid

A leak in the Community Center Pool filter room roof caused damage to a column and beam which was replaced in the fall of 2019. The roof needs to be replaced in order to prevent further damage to the building.

Staff worked with Illinois Roof Consulting Associates (IRCA) to prepare bid plans and specifications, which were sent out to the bidders on June 10, 2020. Forty-two contractors received bid documents.

Bids were opened on June 24, 2020. The results were as follows:

Bid results were reviewed and references were checked. IRCA has recommended rejecting the low bid from Red Feather as it does not line up with the scope of work and the company is primarily a painting company. Combined Roofing has satisfactorily completed work for the district in past and is recommended.

PREVIOUS COMMITTEE/BOARD ACTION:

Hiring IRCA as a roofing consultant was discussed at the June 5, 2019 Buildings and Grounds subcommittee meeting and approved at the following Board meeting.



REVENUE OR FUNDING IMPLICATIONS:

While this work is slightly above budget, our estimate was made using unit costs from other projects that were larger and may have been less complicated than this project.

Additional work that is outside of the scope of a roofing contractor is anticipated for the concrete decks that provide access the top of the water slides. It is possible we are seeing moisture infiltration from cracks below the surface and the drainage plumbing. Staff is currently working with Williams Architects to assess the condition and develop plans and specifications for those repairs.

STAKEHOLDER PROCESS:

Work will be scheduled with Community Center staff. With the pool being closed this season, there should be minimal disruption.

Illinois Roof Consulting Associates, Inc. (IRCA) was authorized to prepare project documents and specifications for the roof rehabilitation at the referenced facility. The following is a summary of our work in this regard and our recommendations for award of the roofing contract.

We collected data at the site and formulated a specification. Once the documents were reviewed and finalized, we provided the Park District with an Advertisement to Bid.

The contractors who responded to the Advertisement were A-1 Roofing, Combined Roofing, DCG Roofing Solutions, J & F Chiattello Construction, Knickerbocker Roofing, L. Marshall Roofing, Premire Contractors, Red Feather Group, and Seal Tight Exteriors. A pre-bid meeting was held at the site on June 17, 2020, at 8:00 A.M. The project's requirements, specifications, and details were reviewed and the roof was examined by the participants. Subsequent to this site meeting, addenda were transmitted to all Bidders of Record.

As originally announced, the Bids were opened at a public meeting on June 24, 2020. Attached is a spread sheet listing the Bid prices received.

After carefully reviewing the bids and verbally confirming both price and scope of work with the second lowest bidder, we are pleased to recommend that the project proceed as specified using Combined Roofing. The low Bidder of Record is recommended for disqualification by IRCA due to the following factors:

- The Contractor is a painting firm and this project is strictly roofing.
- The price submitted is not adequate to buy the required materials for the project and certainly will not cover their labor or overhead and profit.
- The low bidder has indicated that they had the wrong dimensions for the project and submitted a price based on that incorrect data.

Please let me know what is decided and how you wish to proceed.
