No funds provided by the Foundation may be used for any political campaign or to support attempts to influence legislation of any governmental body other than through making available the results of non-partisan analysis, study and research.

Any grant funds or income earned thereon not expended for purposes of the grant must be returned.

Fiscal Responsibility

Play for All Playground & Garden Foundation is responsible for the expenditure of funds and for maintaining adequate supporting records consistent with generally accepted accounting principles.

Reporting Requirements

Upon completion of the program/project, or May 1, 2022, whichever comes first, Play for All Playground & Garden Foundation will upload a final report to its account. The final report will include a description of the program progress, the results achieved, future plans and a complete financial statement. Such report shall supply sufficient information as necessary for the Foundation to determine that the grant is being used for the purposes intended and for the Foundation to fulfill its own public reporting responsibilities. The final report

must be completed and filed with the Foundation by the due date in order for Play for All Playground & Garden Foundation to receive future grants.

Publicity

Play for All Playground & Garden Foundation will allow the Foundation to include information about this grant in the Foundation's periodic public reports, newsletter, news releases, social media postings, and on the Foundation's website. This includes the amount and purpose of the grant, any photographs you have provided, your logo or trademark, and other information and materials about your organization and its activities.
