ADDENDUM NO. 1a-1c, 2 to Agreement for Management of Information Technology Services

WHEREAS, Advanced Intelligence Engineering and Client desire to amend the Existing Agreement pursuant to the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the foregoing and other valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

The Existing Agreement is hereby amended as follows:

- 1a. Section 3: Term of Agreement is amended by replacing the following sentences, "The term of this Agreement shall commence on the date that the Agreement is expected by the Parties (the "Commencement Date") and, unless terminated earlier as provided herein, shall expire three (3) years from the Commencement Date (the "Term")" with "The term of this Agreement shall commence on the date that the Agreement is expected by the Parties (the "Commencement Date") and, unless terminated earlier as provided herein, shall expire one (1) year from the Commencement Date (the "Term")".
- 1b. Section 11a: Termination and suspension language is amended by replacing the following sentence, "This agreement may be terminated or suspended by the Park District, in whole or in part, for convenience and without cause upon five (5) days prior written notice." with "This agreement may be terminated or suspended by the Park District, in whole or in part, for convenience and without cause upon thirty (30) days prior written notice."
- 1c. Addendum to RFP: Information Technology Services: The fixed monthly pricing as listed in the existing agreement as Exhibit C, 1 Pricing, 1.1 Fixed Monthly Pricing shall be amended to the following pricing schedule as listed in Exhibit G:
- 2. In all other respects, the Existing Agreement shall remain unchanged and in full force and effect in accordance with the terms thereof. In the event of any conflict between the terms of the Existing Agreement and the terms set forth herein, the terms of the set forth shall prevail and govern the interpretation of the agreement between the parties hereto.
