Cancellation/rescheduling policy

To reserve face painting date and time, Client agrees to pay a non-refundable deposit of 50% of event total. Client understands and agrees that Artist will not book other events during this time. If Client cancels event for any reason, Artist will suffer losses which are difficult to ascertain. As such, Client agrees that such 50% of event total is forfeited by Client and paid to artist as liquidated damages and not as a penalty. Client and Artist agree that such amount is reasonable. If Client requests a rescheduled date, Artist will make every effort to reschedule on an alternate date which is to the Client's satisfaction, but Artist cannot guarantee the availability of requested date due to previously scheduled events. Clients understands that no refund is made based on cancellation due to weather, and that event balance is due at time of event.

Artist is permitted to cancel services in the event of a personal medical emergency or a death in immediate family, in which case retainers will be refunded if Artist can not find a suitable replacement artist for event. Artist will make every effort to supply or recommend substitute professionals in area, but be advised that rates and availability may vary.

LIABILITY AND TERMS

Contract terms and limitations pertaining to reservation and booking fee

• To reserve face painting date and time, Client agrees to pay a non-refundable reservation booking fee of 50% of event total. Client understands and agrees that Artist will not book other events during this time. If Client cancels event for any reason, Artist will suffer losses that are difficult to ascertain. As such, Client agrees that such 50% of event total reservation and booking fee is forfeited by Client and paid to Artist as liquidated damages and not as a penalty. Client and Artist agree that such amount is reasonable. Client understands that no refunds are made based on cancellations due to weather.

Artist terms and limitations

- Artist is not obligated to paint any portion of the body which cannot be legally exposed or any portion of the body which she
 feels uncomfortable painting.
- · Artist is not required to paint designs which she feels are offensive or derogatory.
- Artist will receive a 5 to 10 minute break following each two hours of work if desired. (If Artist works for two hours only, no break is necessary.)
- · Payment may be made by Cash, Square, Chase QuickPay, or Paypal. (Personal checks are not accepted.)
- Artist may cease painting and leave premises without refund if exposed to extreme adverse working conditions which Client fails
 to rectify when notified. Extreme adverse conditions include but are not limited to personal danger resulting from violent,
 destructive, or inappropriate behavior by children or adults; any type of illegal activities; or any other dangerous conditions.
- Artist will refrain from painting any child who is unwilling to be painted or who is distraught and obviously does not want to be
 painted. (This is for the safety of the child, who must remain as still as possible while being painted.) For children under the age of
 two, Artist reserves judgment to decide if only the hand or arm will be painted rather than the face. Children under the age of
 one cannot be painted.
- · Artist does not supervise children, and each child's safety and behavior is the sole responsibility of the parent at all times.
- Client understands that the artist can provide approximately 12 to 15 designs per hour, but that the total number which are provided per hour is dependent on the design choices by the guests.
- Artist observes a strict well-child policy. No child who has shown symptoms of illness in the last 24 hours will be painted.
 Symptoms include, but are not limited to, fever, vomiting, conjunctivitis (pink-eye), impetigo, head lice, runny nose, productive cough, chicken pox, eczema, ringworm, open sores, severe sunburn, or any other skin condition or contagious disease. This policy is strictly observed to prevent contamination of paints and to prevent spread of disease to others.
- Client understands that some colors of face paint can cause slight, temporary staining and must be removed by first lathering with a mild soap and then washing with water and a washcloth. Some may colors require a extra washing to remove pigment. All face paint should be removed by wiping away from eyes and mouth, and should not be left on skin overnight.
- Client will provide a sheltered and safe location for face painting. For outdoor events, Artist requires a dry, shaded, flat area above 55° F. Client agrees to have alternative bad weather plan in place to move Artist indoors or under sufficient shelter due to bad weather (including but not limited to thunderstorms, rain, hail, windy conditions, excessive heat (above 85° F), or excessive cold (below 55° F). There are no cancellations for rain.
- For indoor events Client agrees to provide a well lit, non-smoking environment.

Liability

- Client is guaranteed that face paints used are professional, FDA compliant, non-toxic, and hypoallergenic. Artist is not liable for
 any allergic reaction or skin reaction to paints. Individuals who have had an allergic reaction in the past or who have sensitive skin
 or skin conditions such as eczema or sunburn should refrain from being painted. If a parent is concerned about face paint causing
 reaction or irritation, Artist will apply a small test patch to skin on arm or hand to check for reaction. Parents may also examine
 list of face paint ingredients to check for possible allergens.
- Client agrees to pay for accidents or injuries caused by patrons or employees to Artist and/or Artist's equipment or supplies.
- Artist will exercise due caution while face painting, but is not responsible for damage to clothing or property of individuals being painted.
