In the event that this performance is cancelled by the officials of the Wheaton Christmas Parade due to inclement weather, Four Star Brass Band agree to be rescheduled for another performance within Wheaton Park District's facilities date to be determined and agreed on by performer and Wheaton Park District.

To the fullest extent permitted by law, Four Star Brass Band shall indemnify and hold harmless the Wheaton Christmas Parade committee its officers, officials, employees, volunteers and agents from and against all claims, damages, losses and expenses, including but not limited to legal fees (attorney's and paralegals' fees and court costs), arising out of or resulting from the entertainers' activities; except to the extent caused in whole or in part by any negligent or wrongful act or omission of a party indemnified hereunder. Four Star Brass Band shall similarly protect, indemnify and hold and save harmless Wheaton Christmas Parade committee, its officers, officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees, incurred by reason of Four Star Brass Band breach of any of its obligations under, or Four Star Brass Band default of, any provision of the agreement.

The Wheaton Park District reserves the right to cancel this agreement at any time for breach of this agreement, or for any reason other than breach of contract upon 7 days notice provided to the entertainers.
