To the fullest extent permitted by law, Go 4 It Entertainment shall indemnify and hold harmless the Light the Torch 5K Night Run committee its officers, officials, employees, volunteers and agents from and against all claims, damages, losses and expenses, including but not limited to legal fees (attorney's and paralegals' fees and court costs), arising out of or resulting from the entertainers' activities; except to the

extent caused in whole or in part by any negligent or wrongful act or omission of a party indemnified hereunder. Go 4 It Entertainment shall similarly protect, indemnify and hold and save harmless Light the Torch 5K Night Run committee, its officers, officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees, incurred by reason of Go 4 It Entertainment breach of any of its obligations under, or Go 4 It Entertainment default of, any provision of the agreement.
