All cords, cables, equipment etc. must be properly and safely positioned so as not to create a trip hazard for patrons and staff.

In the event that this performance is cancelled by the officials of the 4th of July Parade Celebration due to inclement weather, Go 4 It Entertainment agrees to be rescheduled for another performance within Wheaton Park District's facilities date to be determined and agreed on by performer and Wheaton Park District.

To the fullest extent permitted by law, Go 4 It Entertainment shall indemnify and hold harmless the 4th of July Parade Celebration committee its officers, officials, employees, volunteers and agents from and against all claims, damages, losses and expenses, including but not limited to legal fees (attorney's and paralegals' fees and court costs), arising out of or resulting from the entertainers' activities; except to the

extent caused in whole or in part by any negligent or wrongful act or omission of a party indemnified hereunder. Go 4 It Entertainment shall similarly protect, indemnify and hold and save harmless 4th of July Parade Celebration committee, its officers, officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees, incurred by reason of Go 4 It Entertainment breach of any of its obligations under, or Go 4 It Entertainment default of, any provision of the agreement.

The Wheaton Park District reserves the right to cancel this agreement at any time for breach of this agreement, or for any reason other than breach of contract upon 7 days notice provided to the entertainers.
