Remove existing coating and grind edges with diamond hand grinder, Grind Main Floor with walk behind 32" diamond grinder machine, patch all cracks and prepare the floor for new coating.</p> <p>2. Apply 100% solids National Epoxy NL100 pigmented epoxy base coat</p> <p>3. Full broadcast ¼" flake of the customers color choice.</p> <p>4. Apply high solids National Epoxy Polyaspartic top coat to seal the floor.</p> <p>All labor will be paid prevailing wage and Gorilla Floors agrees to the following:</p> <p>A. The most recent Prevailing Wage Rate Determination for the County in which the project is located may be accessed online at https://labor.illinois.gov/laws-rules/conmed/rates.html. Contractors performing work on this project are responsible for determining the applicable prevailing wage rates at the time of the Contract as well as at all times during the performance of the Work. Failure of a bidder/contractor to make such determination shall not relieve it of its Contract obligations.</p> <p>The Contractor acknowledges and agrees that the foregoing notice of periodic revisions to the prevailing wage rates satisfies any obligation of the Public Agency to notify the Contractor of any such revisions to the prevailing wage rates during the term of the Contract.</p> <p>B. The Contractor must include the same prevailing wage requirements in its project specifications and contracts for any subcontractors, which, in turn, must write the same requirements into their project specifications and contracts for lower tiered subcontractors or suppliers.</p> <p>C. The Contractor and each subcontractor must make and keep, for a period of not less than five years from the date of the last payment on a contract or subcontract for public works, records of all laborers, mechanics and other workers employed by them on the project. 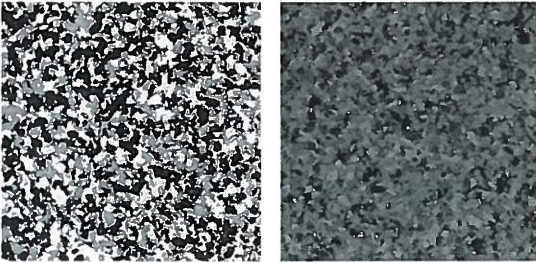
