Terms

- A non-refundable deposit equal to \$884.00 (50% of the total amount due plus a \$10.00 per group fee) must be returned with this executed agreement in order to reserve your block of tickets. Please mail checks to Group Theater Tix, P.O. Box 4771, Skokie, IL 60076 making them payable to Group Theater Tix. Deposits will be refunded only if performance is canceled.
- 3/31/16 Full payment must be received by (three weeks prior to performance date); otherwise, the group will be canceled and tickets released for sale.
- The ticket price is determined by the number of tickets originally ordered through this group sales contract. A reduction or increase in the number of ticktes ordered may affect the price of your tickets.
- You may reduce the number of tickets up to the date full payment is due. Groups falling below 10 persons will be charged the the regular, undiscounted ticket price. There are no ticket refunds after full payment is made.
- Group Theater Tix (is not responsible for refunding unclaimed tickets for prepaid groups.

- The Royal GeorgeTheater is Handicap Accessible. Both the theater and the lobby are located at ground level. Limited wheel chair seats are availble, but must be purchased in advance.
- Payment must be made by check, cash, money order or credit card. No single ticket checks or money orders will be permitted on group orders—only one check per payment will be accepted.
- Tickets will be held at the theater box office or may be picked up at any time prior to the performance once total payment is received. At your request, tickets may be mailed or \$5 per order.
- Additional tickets purchased within two weeks of the performance date must be paid with cash, credit
 card or money order. No checks will be accepted as payment.
- In the event a scheduled performance is interrupted or cancelled payment will be refunded in full, or reservations may be transferred to another performance providing tickets are available and The Group is in agreement. In the case of inclement weather or natural disaster, it is our policy to fulfill the scheduled performance obligations. The Group agrees that, should a performance play despite inclement weather or natural disaster, Group Theater Tix, and The Theatre shall not be liable for any damages due to their inability to attend the performance. This agreement is not limited to tickets only, but also releases Group Theater Tix and The Theatre from any liability for incidental costs (rail, plane, car, cab, charter bus fares, etc... nor for hotel and/or motel expenses).
- Complimentary tickets are offered contingent on the total number of tickets ordered in this Agreement.
 If you choose, in accordance with Paragraph 4, to reduce the total number of tickets ordered, the reduction will be first applied to complimentary tickets before being applied to paid tickets.
- Groups will arrive 30 minutes prior to show time. Late arrivals may be denied entry or seated at the
 discretion of the house staff.
