Frequently asked questions

1. Will my child be required to wear a mask?

Yes, all children in Kidz Kingdom's care are required to wear a mask and must keep it on until they have exited the building. Children will be able to take a mask break in designated areas.

2. How will social distancing be adhered to?

Kidz Kingdom is set up into stations. Each station can have two children in it at a time. Children will rotate stations every 15 minutes. Children will always be encouraged to stay 6 feet apart.

3. Will my child be able to wash/sanitize their hands?

Yes, there are two sinks in Kidz Kingdom. One is located inside of the Kidz Kingdom bathroom and the other sink is in the back of the room. These are available to children as needed. Hand sanitizer is located at the check in desk inside of Kidz Kingdom and also on the back counter. Staff will wipe down the bathroom, bathroom sink, back of the room sink and sanitizer bottle each time they are used.

4. Can my child bring a snack or lunch?

In an effort to minimize risk and slow the possible spread of germs, food is no longer allowed in Kidz Kingdom. Children may bring a water bottle from home.

5. How do I arrange childcare for my Wide Horizon student?

Registration is required in advanced. Students must commit to a semester of before and/or after childcare at Kidz Kingdom the Wheaton Park District must be able to staff childcare appropriately, so reservations are required and no drop-in care will be offered for Wide Horizon's Preschool in the fall of 2020.

Important information

The Wheaton Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Wheaton Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program/activity must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or has recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

Safety procedures & protocols

1. Kidz Kingdom Childcare Attendant will escort child from Wide Horizons Preschool to Kidz Kingdom or from Kidz Kingdom to Wide Horizons Preschool. Mask must be worn by both Kidz Kingdom Attendant and Wide Horizon student/students. A social distance of 6 feet must be practiced. Kidz Kingdom staff will have no contact with Wide Horizon students.
2. Children will be required to wear a mask while in Kidz Kingdom.
3. Children will wash their hands upon entering Kidz Kingdom.
4. Kidz Kingdom will be set up into stations. Two-three children (depending on daily attendance) will be allowed at a station at a time. Children will rotate stations every 15-20 minutes. Each station will be sanitized after a group moves to the next station. Children will sanitize their hands in between each station.
5. Kidz Kingdom Attendant will direct children to socially distance 6 feet from each other when possible.
6. Kidz Kingdom Childcare will be sanitized after a station change and at the end of the day.

Warning of risk

Recreational activities are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational activity. All hazards and dangers cannot be foreseen. Waiver and release of all claims and assumptions of risk

Please read this form carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity (including transportation services and vehicle operations, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the Wheaton Park District, including its officials, agents, volunteers and employees.
