10 payments - \$15,000 Initial payment due September 30, 2019.

1) Permanent name recognition as "Lions Terrace" on the Terrace area adjacent to the Mary Lubko Center at Memorial Park.

\$65,000 Balance due in annual payments of \$7,222.22 over subsequent 9 years by June 30 of 2020 through 2028

- 2) A permanent bronze recognition plaque permanently mounted in the Terrace Area.
- 3) Permanent Signage in Terrace Area that displays the Lions logo and describes the six Pillars of Service that the Wheaton Lions Club provides to the community.
- 4) Wheaton Lions Club shall have the right to reserve "Lions Terrace" without additional cost during one concert event each year that the Wheaton Park District hosts a concert series. Park District will provide 100 concert tickets to the President of the Lions Club for each agreed upon concert date. Food and Beverage costs related to this use will remain the responsibility of the Wheaton Lions Club. Park District and Wheaton Lions Club must mutually agree on the reservation date each summer with an attempt made to give the Lions priority.
- 5) Wheaton Lions Club shall have the right to reserve "Lions Terrace" at no cost for one additional date each year. Park District and Wheaton Lions Club must mutually agree on the reservation date. Staffing and maintenance fees may apply for this reservation.
- 6) The Wheaton Park District reserves the right to program "Lions Terrace" as it sees fit for community use per park district policy.
- 7) The Wheaton Park District reserves the right to rent "Lions Terrace" to other groups for all other concert and/or special event dates throughout each year.
- 8) Communication between the Wheaton Park District and the Wheaton Lions Club related to this grant agreement should be addressed to the Executive Director of the Wheaton Park District and the President of Wheaton Lions Charities respectively.
- 9) DuPage County Illinois18th Judicial District, Wheaton Illinois shall serve as the legal venue related to this grant agreement.
- 10) Notices shall be in writing and served by email, certified mail return receipt requested or in person to the then President of the Wheaton Lions Club or the then Executive Director of the Wheaton Park District, or anyone acting on their respective behalves.
