Commissioner Morrill moved to approve Planning Resource's change order in the amount of \$3,743 supplemental contract in the amount of \$6,702.50 and additional supervision in an amount not to exceed \$880. Commissioner Mee seconded.

3. Election of Officers for the Wheaton Park District Board of Commissioners Commissioner Morrill moved to elect President Kelly as President Commissioner Luetkehans as Vice President, Executive Director Benard as Secretary and Finance Director Rita Trainor as Treasurer. Seconded by Commissioner Mee.

### **NEW BUSINESS**

- Bid Results and Recommendation Atten Park Tennis and Basketball Court Color Coating Project Commissioner Morrill moved to reject the bid and rebid in 2015. Commissioner Schobel seconded. Motion passed by voice vote.
- 2. Bid Results and Recommendation Graf Park Synthetic Turf Project Site Work

Commissioner Morrill moved to approve a contract with the low bidder JEM Morris Construction in the amount of \$563,890. Commissioner Mee seconded.

Commissioner Morrill asked if staff had given any thought to maintenance of these turf fields. Executive Director Benard stated that we have and there will be some cost to maintaining them but no more and most likely less than what we are paying now to maintain the current field. Commissioner Morrill asked how we will disinfect them. Bryron from Wight Engineering stated that the sun takes care of the outside fields but there is disinfectant spray that can be purchased to clean the indoor turf. Staff will provide the board with a report on the disinfectant. Commissioner Mee asked what we will do with the surplus in the budget from this project. Executive Director Benard stated that he would follow up.

Motion passed by roll call vote. Ayes: Hodgkinson, Mee, Morrill, Schobel, Kelly Nays: VanderSchaaf Absent: Luetkehans 3. Approval to Fill a Full Time Vacancy - Athletics Manager Commissioner Morrill moved to approve filling the vacant position of Athletic Manager. Commissioner Mee seconded.

Commissioner VanderSchaaf stated she would like staff to look at the entire department and how it could possibly be re-organized so that the position might not have to be reinstated. President Kelly said that he would like to see on the memo that is given to the board a description of options that were considered before just asking to have the position refilled.

4. Annual Review and Approval of Amendments to the Finance Policies of the Wheaton Park District Commissioner Morrill moved to approve the Finance Policies as long as Staff and the Finance Subcommittee will provide an addendum to the policies giving a clearer definition of what an emergency purchase is. Commissioner Mee seconded.

- 2013 Annual Reports
  - Zoo 2013 Annual Report

Commissioners Hodgkinson, Mee and Schobel all commented on what a nice annual report Zoo Director Sue Wahlgren prepared. Commissioner VanderSchaaf asked what the reason for the rental increases were. Wahlgren stated that she believed it was due to the zoo working with the rental charter and word of mouth from patrons who had parties there. Commissioner Morrill thanked the Cosley Zoo Foundation for all of their fundraising efforts for the zoo.

Executive Director Benard stated that the board will be receiving a summary on the 2015-2019 Strategic Plan. 55 full and part time staff members have been working on the plan. Staff will also provide the board with a follow up to the focus groups and staff will contact the focus group participants to inform them of what staff has been doing with the information that was gathered at the focus groups. The strategic plan will be on the September agenda for board review and possible approval. Commissioner Schobel suggested that staff work with the Garden Clubs and local master gardeners for extra help with beautifying Arrowhead and other parks. Executive Director Benard stated he would have staff look into this.

Commissioner Mee commended Marketing Director Margie Wilhelmi and her staff on all of the great work they are doing for the district, he also commended the Rec and Parks staff on the Post Prom event.

Commissioner Morrill recommended that we do a dedication when the Graf Park Turf is finished. President Kelly said he would also like to see a dedication for Central Athletic Center. Commissioner Hodgkinson asked if we will be getting a sign outside of Central Athletic Center. President Kelly stated that there was some discussion about naming so once that is decided we will have a sign made.
