Four 100 gallon hot water heaters were installed at the time the clubhouse was built in 2006. Two of these tanks developed leaks over the past two weeks and are no longer operational. We have been able to operate on two tanks for the last few days by sectioning off the two disabled tanks. However, with the busy season approaching, we are concerned that the two remaining tanks will not be able to keep up with demand and/or the extra demand placed on these units could cause one or both to fail. A failure of either of these units would likely mean that all food and beverage operations would need to be closed until replacements could be installed.

REVENUE OR FUNDING IMPLICATIONS:

This is an unbudgeted item but will be funded from the Arrowhead operating budget.

Quotes were received from four vendors for the replacement of the two units. They are as follows:

A low quote was identified and Board President John Kelly met with vendor - Armbrust and staff to review the project. It was decided that one of the old units needed to be moved in order to balance the system which added some additional cost to the original project (quoted as not to exceed \$1,995). President Kelly agreed that the units needed to be replaced along with the additional work. Permission to proceed with the project was given.

SUMMARY:

The tennis courts at Atten Park are in need of repair. Traditional methods for making the necessary repairs have not produced a long lasting solution to cracking over the life of the courts.

Traditionally new asphalt is installed every 15 years and warrantied for one year. Crack repairs and color coating are done about 7 years after the initial install but are not warrantied. Cracking often re-appears in a year's time.

Staff researched various products and found that membrane systems appeared to provide the best solution with the best warranty (a five-year rolling warranty, extending up to 25 years with proper inspections and maintenance). While the initial cost is higher than our previous methods, we believe the long term cost savings and improved surface will prove better.

Staff contracted Fred Kolkmann Tennis & Sport Surfaces LLC to develop plans and specifications necessary to bid this type of surfacing. The base bid is for the complete installation of a membrane surface as well as crack repair, color coating and striping. An alternate bid for just crack repair, color coating & striping was included.

Bids were solicited on April 14, 2015 and they were opened on April 29, 2015. The results were as follows:

While we are disappointed in the number of responses, it is consistent with what we have seen in the past. There are a limited number of contractors who focus on this type of work.

References for MTJ Sports were checked and were favorable. The manufacturer of the membrane system will also be present during construction to ensure proper installation.

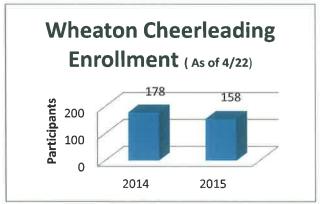
Athletics

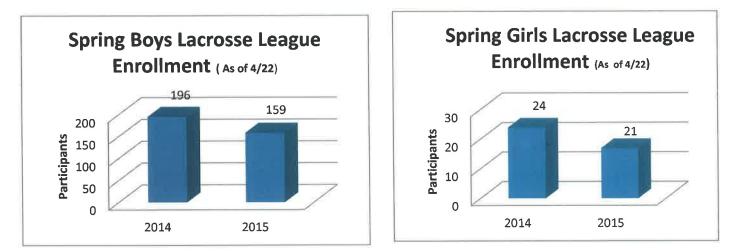

- The Rams cheerleading and football coaches are attending preseason coaching instruction clinics to help improve skills and knowledge of the sport.

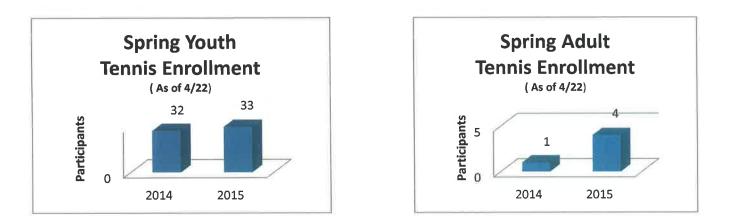




- Men's Spring Recreational Basketball League is underway with games at the Community Center gym. We have seven teams, which is consistent with last year.

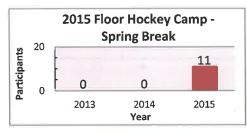


• The Spring Tennis (youth & adult) instructional classes began on April 8. Classes are held at Seven Gables Park on Saturdays from 1 to 5 pm.

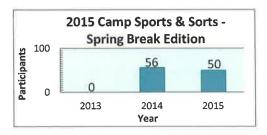

Arrowhead Golf Club-Bruce Stoller, Director

- High temperatures in April averaged just above normal as cool periods were balanced by warm as is often the case this time of year. April was the eighth consecutive month with below average precipitation. Only 67 percent of the normal precipitation has fallen since September 1st of last year.
- Registration continues for the PGA Junior League and it now appears that we will have the full four teams that we were hoping for. This will allow us to host our own league and means that at least three times as many children will participate in the program through Arrowhead this year as did in 2014.
- Plant material has been chosen for the beds on the driving range. It will be delivered and installed as soon as it is available from the growers. Sod has also been put down in the practice area to cover areas that were disturbed late last year when new irrigation was installed in the area.
- Bids were opened April 6th for the cart path asphalt work to be done this year. The bid was approved later in the month and work will be done as soon as it can be coordinated with the contractor and golf course schedule.
- Staff attended the pre-season coffees for the Wheaton senior men's and women's golf leagues to answer questions and set the schedule for the upcoming season. Almost 200 seniors take part in the two leagues which play every Wednesday morning from early May through September.
- The annual free clinic and demo day took place April 18th with over 50 people in attendance. A new format allowed people to cover all phases of the game in one day instead of spreading it out over two days. The change was made in response to suggestions from a number of past attendees and was well received.
- Selected areas on a few greens were aerated during the middle of the month to help them come out of the winter a bit more quickly. These areas are much smaller and fewer in number than last season and were almost 100 percent healed within a couple of weeks.

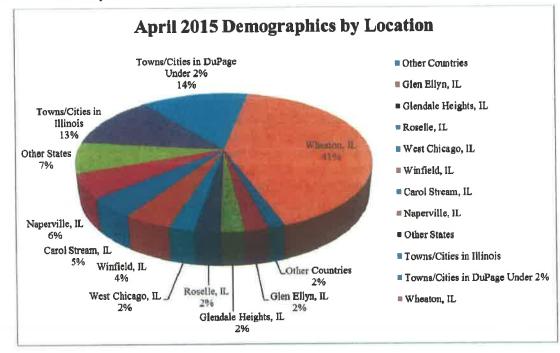
