

RESOLUTION R-2026-24

A RESOLUTION AUTHORIZING THE EXECUTION OF AN AMENDMENT TO EXHIBIT C TO THE LICENSE AGREEMENT WITH WHEATON PARK DISTRICT/MEMORIAL PARK (WHEATON MUNICIPAL BAND)

WHEREAS, the City and Park District entered into an agreement (“Agreement”) on March 15, 2023, for the purposes of the Wheaton Municipal Band’s access to, operations, and use of portions of Memorial Park and the Bandshell for storage, rehearsal, and summer concert series; and

WHEREAS, Section 5.1 of the Agreement provides that the initial term of the Agreement expired December 31, 2023; and thereafter the Agreement will automatically renew for successive one-year terms; and

WHEREAS, Section 3.2 of the Agreement states that the dates and times for the Band’s practices and concerts, which are set forth on Exhibit C to the Agreement, “shall be amended on an annual basis by mutual written agreement of the Parties” for each upcoming year; and

WHEREAS, the Park District has provided the City with a proposed amended Exhibit C reflecting the performance and practice schedule for 2026.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that the Mayor is hereby authorized to sign an Amendment to Exhibit C (attached hereto) to the License Agreement with the Wheaton Park District for access and use of portions of Memorial Park.
