Working with Williams Aquatics, the district developed plans for stairs into the pool at Northside to serve as a secondary means of ADA access for the pool. Plans were sent to contractors on January 22, 2019. Six contractors received bid documents. Bids were opened on February 6, 2019. The results were as follows:

Schaefges Brothers Inc. has successfully completed pool related projects for the park district in the past.
