SUMMARY:

As part of the yearly Arrowhead cart path repair and replacement project, staff identified areas in need of replacement throughout the property. The parking lot at the front entrance was also deemed to be in poor condition and in need of replacement. Plans and specifications were prepared by staff and bid documents were sent out to contractors on June 2, 2023. Bids were opened on June 22, 2023, and the results were as follows:

^{*}The low bidder, Matthew paving did not provide a bid bond or check for the bid surety. According to the legal notice and bid documents, failure to provide this requires rejection of the bid. Staff discussed this issue with our attorney, and it was recommended that the contractor's bid be rejected.

Staff checked the references of the next lowest bidder Obsidian Asphalt, and the references were found to be favorable.
