RE: 2026 Ray Morrill Community Center Interior Renovation – Phase III

### **SUMMARY:**

Staff has been working with Williams Architects on continued renovations to the Ray Morrill Community Center. Phase 3 will address renovations on the first floor, including a new front desk area, alterations to the north entrance and gym corridor, and a new preschool floor plan. Three alternates were also included as part of the project, and are as follows:

- Alternate No. 1: Gymnasium and Gym Corridor
- Alternate No. 2: Painting of Upper Entry and Lounge
- Alternate No. 3. Concession window at Appleby Kitchen

Staff sent out bid specifications to 22 companies on December 3rd, 2025. The bids were opened on December 17th, 2025, and the results are as follows:
