Scope of Architectural Services:

StudioGC shall provide the following project specific scope of services for the Wheaton Park District (WPD) for the design and construction administration for a new agrichemical maintenance and storage facility at the Arrowhead Golf Club, per Exhibit A.

- · Review field conditions, Owner provided surveys and site related data.
- Provide design services for the Agrichemical Storage Building, including regulation and code reviews.
- Coordinate all service and design work Owner's civil engineer for project.
- Prepare construction documentations Including front end and technical specifications sections.
- Provide bidding services per the Wheaton Park District procurement process.
- Provide construction administration services through project completion.
- Assistance with the Illinois Department of Agriculture Agrichemical Facility Registration Application

Compensation

However, coordination with WPD Civil Engineer is included. StudioGC will assist the Wheaton Park District in soliciting proposals for these services if necessary.
