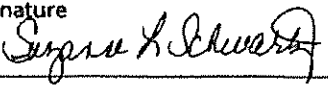

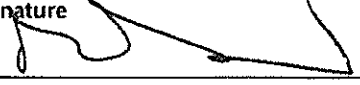
Schwartz breach of any of its obligations under, or Suzy Schwartz default of, any provision of the agreement.
