If inclement weather does take place the event and its officials will do everything in their power to go on with the schedule. Bands must understand that their performance times may be adjusted slightly (forward or back) to accommodate any unforeseen circumstances.

The Wurst Kase Oktoberfest Band shall similarly protect, indemnify and hold and save harmless the October Fest/Night Run committees, its officers, officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees, incurred by reason of The Wurst Kase Oktoberfest Band breach of any of its obligations under, or The Wurst Kase Oktoberfest Band default of, any provision of the agreement.

The Wheaton Park District reserves the right to cancel this agreement at any time for breach of this agreement, or for any reason other than breach of contract upon 7 days notice provided to the entertainers.
