Hourly Rate: \$150

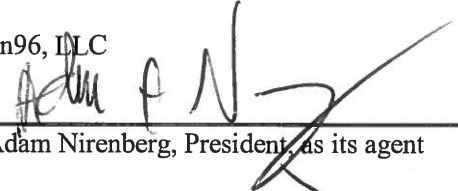

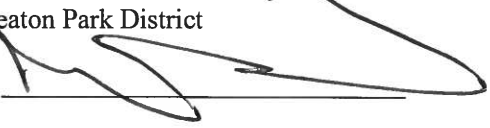

- Conduct finalist presentation meetings; and
- Support Wheaton Park District with vendor negotiation and the selection of a final vendor.
