- Communicate with the Wheaton Park District Project Manager to understand any installation changes approved at the above facilities;
- Coordinate with the IT Department to ensure they are satisfied with the completion of each sites installation;
- Conduct detailed onsite reviews at each facility as they are completed by the Vendor. This should include a review/discussion with Imperial;
- Identify any issues with the final installation and present to WPD/Imperial for resolution;
- Follow-up on corrective action completed by Imperial based on any issues identified; and
- Assist WPD PM during installation at facilities, regarding interpretation of requirements.

Estimated Hours Range: 120-160


Estimated Cost Range: \$18,000 - \$24,000
