In the event that this performance is cancelled by the officials of the Wheaton Independence Day Parade due to inclement weather, Wheaton Warrenville South High School agrees to be rescheduled for another performance within Wheaton Park District's facilities date to be determined and agreed on by performer and Wheaton Park District.

To the fullest extent permitted by law, Wheaton Warrenville South High School shall indemnify and hold harmless the Wheaton Independence Day Parade committee its officers, officials, employees, volunteers and agents from and against all claims, damages, losses and expenses, including but not limited to legal

fees (attorney's and paralegals' fees and court costs), arising out of or resulting from the entertainers' activities; except to the extent caused in whole or in part by any negligent or wrongful act or omission of a party indemnified hereunder. Wheaton Warrenville South High School shall similarly protect, indemnify and hold and save harmless Wheaton Independence Day Parade committee, its officers, officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees, incurred by reason of Wheaton Warrenville South High School breach of any of its obligations under, or Wheaton Warrenville South High School default of, any provision of the agreement.

The Wheaton Park District reserves the right to cancel this agreement at any time for breach of this agreement, or for any reason other than breach of contract upon 7 days notice provided to the entertainers.
