

In the event that this performance is cancelled by the officials of the Ice-A-Palooza due to inclement weather, Your Magical Moment, agrees to be rescheduled for another performance at the Wheaton Park District, date to be determined and agreed on by performer. If a date cannot be agreed upon to rebook for the full payment set forth by this contract, 50% of the agreed upon price will be paid to the band. If inclement weather does take place the event and its officials will do everything in their power to go on with the schedule. Bands must understand that their performance times may be adjusted slightly (forward or back) to accommodate any unforeseen circumstances.



The Wheaton Park District reserves the right to cancel this agreement at any time for breach of this agreement, or for any reason other than breach of contract upon 7 days notice provided to the entertainers.
